One Statistical Officer Mr. Aakash Mishra, Statistician cum Assistant Professor, Department of Community Medicine, MGMC&H and one Data Entry Operator of Mahatma Gandhi Medical College shall assist the cell.

Objectives and Functions of the Cell -

- 1. To implement the reservation policy for Minorities candidates in admissions to various courses in the colleges of the University.
- 2. To collect data regarding the implementation of the policies in respect of admissions and analyze the data showing the trends and changes towards fulfilling the required quota.
- 3. To take such follow up measures for achieving the objectives and targets laid down for the purpose by the Government of Rajasthan, Government of India and the UGC.
- To monitor and evaluate continuously the reservation policy and plan measures for ensuring effective implementation of the policy and program of the Government of Rajasthan, Government of India and the UGC.
- To circulate decisions of the Government of India and National Commission for Minorities and to collect regularly, on annual basis information regarding course wise admissions to candidates belonging to the Minorities in the University Colleges in forms prescribed by stipulated date and to take follow up action, where required.
- To analyze the information collected above and prepare reports for onward transmission to Ministry of Human Resource Development, University Grants Commission and such other authorities as may be required.
- 7. To deal with representations received from Minorities candidates regarding their admission and other similar matters in University Colleges.
- 8. Any other work assigned from time to time to promote higher education among the community suffering economic, social and education deprivations.
