

#### Minutes of Forty second Meeting of Board of Management (MGUMST) (September 03, 2024)

Forty second meeting of the Board of Management of the Mahatma Gandhi University of Medical Sciences and Technology, Jaipur was held on Tuesday, September 03, 2024 at 2:00 P.M. in the Board Room, R.K. Academic and University Block of the University.

The list of members who attended the meeting is appended as **Annexure-1**.

Professor I.K. Bhat participated in the meeting through Video Conferencing. Dr Ashok Khandaka and Dr Girdhar J. Gyani being out of India and Shri Pukhraj Sen, IAS, Commissioner, College Education being busy in a meeting with hon'ble Minister (as informed by the P.S. to the Commissioner) could not attend the meeting.

Dr Sudhir Sachdev, Chief Advisor to Chairperson, MGUMST, Dr N.D. Soni, Dean & Principal, MGMC&H and Shri R.N. Kogata, Financial Advisor attended the meeting as special invitees and Dr Hari Gautam, special invitee participated in the meeting through Video Conferencing.

The Chairman accorded a cordial welcome to all the members of Board of Management specially to Shri Tilak Raj Bajalia, Former Deputy Managing Director at SIDBI (Small Industries Development Bank of India), Mumbai, who was attending the meeting of the Board for the first time. He introduced Dr Bajalia to all the members of the Board. He appreciated all the members for their contribution made towards growth of the University. 6.	recommendations of	The Board considered and approved the recommendations of the Academic Council made at its meeting held on August 06, 2024.

#### 7. Items with the permission of the Chair -

- i) It was apprised by the President that the matter of security on the campus has been taken seriously by the University Authorities. In this regard a meeting of all concerned officials including the Dean & Principal, MGMCH, Medical Superintendent, MGH, Chief Security Officer, MGUMST, Chief Warden, University Hostels and others has been conducted on September 02, 2024. The Board discussed the matter of security and safety of the students, employees, their families in the University campus and patients in the hospital as well as fire safety measures in the University premises and resolved that regular meetings of the concerned officials need to be conducted every month and necessary action be taken promptly.
- ii) The President apprised the Board that meetings of the students of medical and dental colleges and their parents have been conducted recently by the College and University Authorities. The students and their parents have been informed about the regulations related to the ragging, minimum required attendance in theory and practicals, discipline on the campus etc.
  - The Board appreciated the initiative taken by the colleges and the university authorities to make aware the students and their parents about the importance and necessity of attendance, discipline, anti-ragging etc. The Board resolved that DEEKSHAPRARAMBH programs be organized for every fresh batch of the courses being conducted in the colleges. In this program the freshers be informed about the discipline, respect of teachers, hostel rules, minimum required attendance in theory and practicals, internal/continuous assessment, moral ethics, narcotics/liquor/smoking free campus, ban on single use plastic items and ban on any battery/motor driven vehicles in the campus etc.
- iii) The Board members were informed that Dr M.L. Swarankar tendered his resignation to the India Education Trust from the position of the Chairperson, MGUMST on June 10, 2019. His resignation was accepted by the Governing Council of the Trust on June 18, 2019. Consequently, the Board of Management in its meeting held on June 27, 2019 requested him to accept a new responsibility with designation named as Emeritus Chairperson of the University. He was also requested to continue to be in

the position of Professor of Obstetrics and Gynaecology a post which he had already been in. The Board requested him to accept the proposal which he so kindly agreed to. Accordingly, he agreed to accept his remuneration only in technical/professional capacity.

The Board members very much wished and expressed that it would be better for this Institution if Dr M.L. Swarankar resumes and contributes for providing the desired boost and progress to the University which has so far already gained name and fame and has proven as one of the most promising and progressive Medical Institution. In fact, and indeed he is the man who conceived, created and promoted this establishment first as a Medical College thereafter a Medical University and then developed it further to make it a pioneer and premier institution not only of the state of Rajasthan but of the Country as well. The Chairperson proposed that as University is undergoing a major expansion in health care facilities (addition of Silver Jubilee Towers A & B) and addition of newer courses, active guidance of Emeritus Chairperson is needed for rapid progress and development.

Request of the members of the Board was gracefully accepted by Dr M.L. Swarankar and he agreed to come back to full time salaried structure. The Board members thanked him for accepting the request as above. The Board also resolved that his remuneration should be enhanced by the University accordingly in technical/professional capacity and in administrative capacity.

iv) The Emeritus Chairperson proposed that the University now onwards should purchase passenger vehicles – four wheelers (other than bus/ambulance etc.) costing not more than Rs. 50 lacs. Toyota Innova or similar vehicle (of same or lower price value) may be provided to faculty members or senior officers wherein it is mutually agreed to provide a vehicle for local transport as per offer/appointment letter.

The Board unanimously agreed with the proposal of the Emeritus Chairperson as above.

v) The Chief Finance & Accounts Officer submitted that the University needs certain resolutions to be passed by the Board of Management regarding modification in signatory in OD Account, converting various existing banking accounts into Collection Accounts and closing of Bank accounts.

The Board considered the matter as explained by the CF&AO as under:

#### A. Modification in Signatory in OD Account No. 125005506728 (Canara Bank):

In view of closure of current account, from where the refunds to patients were made, we have to give authority to staff members for making payment of refunds to patients up to a limit of Rs 2,50,000/- from OD account number 125005506728 and necessary resolutions are required. The existing signatory would also continue.
