

## Minutes of Forty first Meeting of Board of Management (MGUMST) (June 08, 2024)

Forty first meeting of the Board of Management (BOM) of the Mahatma Gandhi University of Medical Sciences and Technology, Jaipur was held on Saturday, June 08, 2024 at 11:00 A.M. in the Board Room, R.K. Academic and University Block of the University.

Before taking up the main agenda items, the Member Secretary with the permission of the Chairman requested the President to apprise the Board about the progress made by the University after March 21, 2024.

  - 1. Opening of an Escrow Account

As the university has been availing various credit facilities from the Consortium members viz. PNB, Canara Bank and UBI, the entire collection from all the activities of the university is to be deposited in the Escrow Account to be maintained with one of the consortium members. The university proposes to open the Escrow Account with the Canara Bank, MGUMST Branch, Jaipur.

#### 8. Items with the permission of the Chair -

### i) Purchase of land parcels after the establishment of the University in 2011.

While deliberating on the issue of the development of the Mahatma Gandhi University of Medical Sciences and Technology (MGUMST), Jaipur, its infrastructure and its perspective in the time to come, it was informed by the Financial Advisor that construction is going on speedily not only in the campus but also on almost all the land pieces purchased by the University after its establishment in 2011. For the purchase of all kinds of plots/land/building in or out side Jaipur from RIICO limited or any other Government Authorities, the Board has already authorized Dr. Vikas Chandra Swarankar, Chairperson, Shri Ram Ratan Soni, CEO & Member, Board of Management and Dr A K Sharma, Registrar in February, 2021.

The Board noted and appreciated the authorities for the rapid progress being made by the University in developing the infrastructure for establishment of additional college, centres, institutions, specialized laboratories and other units.

The Board resolved that the information regarding following land parcels purchased in Jagatpura, Sitapura, Ramchandra Pura etc. from RIICO Ltd. after the establishment of the University in 2011 be communicated to the
