

Minutes of Fortieth Meeting of Board of Management (MGUMST) (March 21, 2024)

Fortieth meeting of the Board of Management (BOM) of the Mahatma Gandhi University of Medical Sciences and Technology, Jaipur was held on Thursday, March 21, 2024 at 2:00 P.M. in the Board Room, R.K. Academic and University Block of the University.

The Chairman accorded a cordial welcome to all the members of Board of Management specially to Dr Achal Gulati, the President, who was attending the meeting of the Board for the first time. - i) Renewal of license to run Mahatma Gandhi University of Medical Sciences & Technology Security Agency, Jaipur

It was informed to the Board that in the meeting of the Board of Management held on September 26, 2018, it was decided that the MGUMST be authorized to run its own Security Agency under "Private Security Agencies (Regulation) Act, 2005" and "Rajasthan Private Security Agencies (Regulation) Rules, 2006".

On the application of the MGUMST, M/s. Mahatma Gandhi Medical College & Hospital – a unit of MGUMST (Sponsoring Body: India Edu. Trust), through it's proprietor Dr Ajay Kumar Sharma (Registrar) was issued license to engage in the business of Private Security Agency vide serial no.: 1821/HG HQ (S-Cell)/2018 dated 22.01.2019 valid up to 21.01.2024.

Before the expiry of the last date of the validity of the license, the University well in time on 10.11.2023 submitted an application for renewal of the license. As decided and directed by the Authorities, a request was also made vide letter no. MGUMST/Academic/2023/2135 dated 29.11.2023 to the Controlling Authority to amend the name of the licensee (security agency) from M/s. Mahatma Gandhi Medical College & Hospital – a unit of MGUMST (Sponsoring Body: India Edu.
