MAHATMA GANDHI UNIVERSITY

MEDICAL SCIENCES & TECHNOLOGY

As per Section 13 of Private Universities' Laws Amendment Act, 2018, the President shall be appointed by the Chairperson from a panel of not less than three and not more than five persons recommended by the Board.

The process of appointment of President is to be initiated as per the Section 13 and applications are to be invited from eligible persons through public notice. Eligibility for a person to apply for the post of President is inclusive of the following -

- (i) He should be distinguished academician of highest level of competence, integrity, morals and institutional commitments. He should have exposure to the higher education system in the Country and adequate experience in academic and administrative governance.
- (ii) He should have a minimum of 10 years experience of Professor in a University or College OR ten years of experience in an equivalent position in a reputed research and/or academic administrative organization.
- (iii) The term of office of the President shall be three years from the date on which he enters upon his office or until he attains the age of 70 years, whichever is earlier.

Out of the eligible applicants whose applications are received in response to the public notification of the University, the Board shall recommend a panel of three to five

eligible persons to the Chairperson for selection of the President.

The Board after due deliberations resolved that the process of appointment of President may be initiated as per the Section 13 and applications be invited from eligible persons through public notice.

The Board further resolved to form a Search Committee headed by Emeritus Chairperson Dr M.L. Swarankar to scrutinize shortlist the applications that shall be subsequently received in due course of time for the post of the President. Other two members of the Search Committee shall be Professor (Dr.) Ranbir Singh, Founder Vice-Chancellor, National Law University, Delhi and Dr B S MS-Neuro Sharma, Surgery. Thenafter, Dr. Sudhir Sachdev was requested to join the deliberations which he gracefully accepted.

iii) For applying for verification of the title "Journal of Mahatma Gandhi University of Medical Sciences and Technology" by the office of the Registrar of Newspapers for India (RNI), New Delhi.

The Board was informed by the Special Invitee Dr G.N. Saxena, Pro-President of the University that the "Mahatma Gandhi University of Medical Sciences and Technology" intends to apply for verification of the title "Journal of Mahatma Gandhi University of Medical Sciences and Technology" by the office of the Registrar of Newspapers for India (RNI), New Delhi.

The Board discussed and decided that the university should apply for verification of this title which should be published as societies thrice in a year (Triannual) journal covering,

- · To promote practice, education and research in the field of health.
- To promote the exchange of current and innovative procedures as well as basic clinical research in all areas.
- To focus on clinical research to enable the researchers to communicate their findings.
- · To promote student research in the field of health.

After due deliberations the Board resolved that pursuant to the applicable provisions of Press & Registration of Books Act 1867, as amended from time to time and read with rules made there under, the consent of the Board of Management be and is hereby given:-

- To apply for the title "Journal of Mahatma Gandhi University of Medical Sciences and Technology" in the name of the university i.e. "Mahatma Gandhi University of Medical Sciences and Technology" to be published as thrice in a year journal in English language from Delhi as its place of publication and printing;
- To authorize Shri Jitendar Pal Vij as applicant to apply for this title for and on behalf of the university and to take all necessary actions in this connection.
- To appoint Shri Jitendar Pal Vij as Publisher & Printer of the forthcoming journal titled Journal of Mahatma Gandhi University of Medical Sciences and Technology and after verification of this title in favour of the university by the office of RNI, to file declarations before appropriate licensing authority at the place of publication and printing and to apply for RNI's registration certificate as per prescribed norms.
