College & Hospital and resolved that upgradations of all the institutions of the University should be taken up rather than focusing only on the Medical College & Hospital.

It was informed that Medical College Alumni shall meet on 30th October, 2022. The Board resolved that Principals of all the colleges of the University be requested to arrange for alumni meets of respective colleges frequently. They should plan the alumni meets and submit its calendar to the University.

Regarding the seven criteria for accreditation by NAAC, the Board resolved that each criteria head should have a calendar of activities related to his/her criteria.

To strengthen the IQAC, the Board expressed that experienced active external members should also be included in the IQAC.

Regarding workshop activities being conducted mandatorily, the Board that Medical resolved Education Technology (MET) - Workshop activities be increased. Further, to accelerate research activities and publications, more research work be done in specific areas like organ transplants, oncology including lymphoma etc. and the progress of research work publications be reviewed quarterly by a committee consisting of all the Principals headed by the Pro-President.

## Dr K.D. Gupta Memorial Oration.

Dr Krishan Dayal Gupta born on October 12, 1922 in Bikaner and graduated in 1946 from King Edward Medical College, Lahore, did MD in Internal Medicine in 1949 from Government Medical College of Punjab University. He was known for his clinical acumen and academic depth and breadth. In 1956 Dr Gupta was awarded international award from the pharmaceutical company Lederle Inc. He was a fellow in allergy and immunology at the Temple University School of Medicine in Philadelphia, United States, for two years. After returning from the United States, in 1958 he started India's first allergy clinic in Jaipur at the Sawai Man Singh Hospital. In 1971, he became Principal, Sardar Patel Medical College, Bikaner. He served as the Dean of the Faculty of Medicine at the University of Rajasthan and as a visiting professor in leading institutions including the Postgraduate Institute of Medical Education and Research, Chandigarh.

He served as the Chairman of the Rajasthan Red Cross. He was major force in the establishment of the Mahatma Gandhi Institute of Medical Sciences, in the state.

Dr Gupta published over 200 publications in fields of allergy and immunology, liver disease, and cardiovascular pathophysiology in national and international journals.

### Dr G.C. Sharma Memorial Oration

A brilliant surgeon and outstanding teacher, Dr Gopal Chandra Sharma was an epitome of what a surgeon ought to be and an example for all of us to emulate.

Born on 29th Dec 1924, Dr G.C. Sharma completed his MBBS and MS (General Surgery) from Grant Medical College Bombay respectively in 1942 and 1949. He trained as a Surgical Resident at Mount Sinai Hospital, New York in 1951-52. He served as Lecturer (1952-55) and Reader (1955-63) at the SMS Medical College, Jaipur. He did advanced training in Cardiothoracic Surgery at University Hospital Ann Arbor, Michigan. He was appointed as Principal of SMS Medical College, Jaipur. After his retirement in 1979, he became the Director of the Mobile Surgical Unit of Rajasthan State for 3 years, while continuing to serve as Professor of Cardiothoracic Surgery.
