

Minutes of Thirty Fifth Meeting of Board of Management (MGUMST) (June 17, 2022)

Thirty Fifth meeting of the Board of Management (BOM) of the Mahatma Gandhi University of Medical Sciences & Technology, Jaipur was held on Friday, June 17, 2022 at 2:00 P.M. in the Board Room, R.K. Academic and University Block of the University.

The list of participants who graced the occasion is appended as **Annexure-1**. Out of total 13 members, 09 members including the Chairman participated in the meeting.

Dr Hari Gautam and Dr Sanjiv Agarwal participated in the meeting through Video Conferencing. Dr M.C. Misra, Professor I.K. Bhat and Dr B.S. Sharma could not attend the meeting. Also Smt. Suchi Tyagi, IAS, Commissioner, College Education being busy at Legislative Assembly ongoing session, could not attend the meeting.

Dr G.N. Saxena, Pro-President, Dr Swati Garg, Dean & Principal, MGMC&H, Dr Narendra Padiyar, Dean & Principal, MGDC&H and Shri R.N. Kogata, Financial Advisor attended the meeting as special invitees.

fertility center owned by Dr. M L Swarankar and Smt. Meena Swarankar for the period from 16.04.2020 to 15.04.2022 for the said purpose of getting the teaching and training of Post Graduate Students admitted under this course.

On account of the above, MGUMST has been able to add 02 seats in M. Ch. (Reproductive Medicine and Surgery). The above-mentioned leased premises were being earlier run as an IVF Centre at Bani Park, Jaipur by Dr. M L Swarankar & Smt. Meena Swarankar jointly for last 32 years under the Brand Name "Jaipur Fertility Centre".

The agreement executed in 2020 for the period of 16.04.2020 to 15.04.2022 has already expired & since the university is already on lookout for a new space, which is almost at final stage at Sahakar Marg, Jaipur and therefore the existing premises may not be required now in future. However, the university is still using the premises for its purposes and would require the same till 30.06.2022.

As such, necessary decision is now required for continuation of this centre and / or taking new premises.

The matter was discussed in detail and the following resolutions were passed unanimously-

"RESOLVED THAT the period of lease for existing premises at 40, Sindhi Colony, Bani Park, Jaipur be and is hereby extended for the period up to 30.06.2022 on rent as decided by President and the actions taken by President of University in allowing to continue the same till this Board of Management meeting and making payment of lease rental for this period be and is ratified and approved."

"RESOLVED FURTHER THAT Mr R R Soni, CEO & Member - Board of Management of the university be and is authorised to take all necessary steps in finalising the new premises at any place in Jaipur, for negotiating terms & conditions including period, rent, increase of rent etc. and to take all necessary steps in this connection as deemed fit by him."

10. To consider MGUMST Infrastructure Expansion Plan and Renovation of Mahatma Gandhi Medical College & Hospital Buildings.

Shri R R Soni, CEO & Member – Board of Management of the university informed the Board that the University has proposed to implement an expansion project, where the nursing & paramedical courses would be undertaken in a separate building other than Medical College and Hospital. The objective of this project is to facilitate adequate space to existing medical college, dental college, hospital and also for students of nursing and paramedical courses.

The University has additionally proposed to add MD/MS and DM/MCh seats by 11 and 13 respectively.

Besides above, the university is also proposed to construct Urban Health, Training Centre, Backup Stores and Roads, doing work of Roads, Drainage and Electrical Line Shifting in Medical College and Hospital.

He further informed that the total estimated cost outlay is presently estimated at Rs 81.40 Cr proposed to be funded out of term loan of Rs 50.80 Cr and internal accruals of Rs 30.60 Cr (subject to approval of the same by banks) and the new buildings are proposed to be constructed on the following plots already acquired by the university-

- i) Land at IS-2023 C (Corner) at Ramchandrapura, EPIP, Sitapura, Jaipur for Nursing and Paramedical Building.
- ii)Land at CP4 221, RIICO Industrial Area, Apparel Park, Jaipur for Backup stores.
- iii) Land at C-56, Shiv Officers Colony, Jagatpura, Jaipur for UHTC.
- iv) Work of Roads, Drainage and Electrical Line Shifting in Medical College and Hospital in the existing premises at 12-14, 14A, 18, 19-20, 21, RIICO Institutional Area, Sitapura, Tonk Road, Jaipur

The Board of Management discussed the same in detail, approved the same and passed the following resolution unanimously-

"RESOLVED THAT Dr Vikas Chandra Swarankar, Chairperson and Shri R R Soni, CEO & Member - Board of Management be and are hereby authorised severally to take all necessary actions in connection with the expansion plan of having separate building for Nursing & Paramedical back courses, up store, construction of Roads, Drainage and Line Shifting Electrical including discussion and approval from banks, deciding on cost outlay, term loan, change of scope of work and all other matters in this connection."

11. Items with the permission of the Chair -

Opening of New Pharmacy Institute in Mahatma Gandhi University of Medical Sciences and Technology (MGUMST), Jaipur

It was submitted by the President that looking to the interest of 10+2 passed out candidates and their parents in the field of Pharmacy, the university must establish an institute - Mahatma Gandhi Institute of Pharmacy and start following Diploma and Degree programs in Pharmacy already permitted by the State Govt. under Schedule-II of the MGUMST Act, 2011:

1. Under Graduate Course

Bachelor of Pharmacy (B.Pharm.)

2. Diploma Course

Diploma in Pharmacy (D.Pharm.)

In the above matter it was reported to the Board that the Pharmacy Council of India vide its letter 14-56/2019-PCI(Moratorium)/3720-3826 dated 17 July, 2019 has put a moratorium on the opening of new Pharmacy Colleges for a period of five years w.e.f. 2020-2021, nevertheless, the University has already requested vide letter no. MGUMST/Registrar/Acad/2019/3245 dated 4.12.2019 to the Registrar-cum-Secretary Pharmacy Council of India to permit us to open a Pharmacy College and Start Pharmacy Programs.

It was also reported that recently on May 31, 2022, Hon'ble Supreme Court of India has given directions to the Pharmacy Council of India to relax moratorium for certain appellants, who had approached the Apex Court.

In view of this, the Board accepted the aforesaid proposal of the President and resolved that the University must again make efforts towards obtaining permission from the Pharmacy Council of India for opening of **Mahatma**
