4. Submission of original documents: All candidates who wish to participate in residual seats allotments process must bring all the original documents and undertaking as given in the instruction booklet available at the website.
5. The candidates having other eligibility criteria as XI shall be considered for allotment after exhausting the candidates having eligibility criteria between I to X.

As per observation dated 08.04.2022 of Hon'ble High Court in SBCWP no. 5025/2022 (Sonakshi Kaushik) and in SBCWP no. 5565/2022 (Kiran Meena), only candidates allotted and joined a seat in round 2 state counseling and subsequently allotted a seat in All India stray vacancy round are allowed to resign upto 10.04.2022, 2.00 pm after fulfilling the requisite bond conditions and producing allotment letter downloaded from the official website of MCC.
7. **For admission on residual seats of private medical colleges, candidates are required to contact the concerned medical college directly.**
8. **Registered candidates under NRI quota** and who are eligible to participate in residual NRI seat allotment process and are having valid documents for consideration under NRI seat allotment are required to present themselves before the Board, alongwith all relevant original documents as mentioned in the Information booklet, including document showing proof of relation between the candidate and sponsor and also the document relating to taking state priority.

According to Government directions, NRI seat remaining vacant due to non-availability of eligible NRI candidate shall be converted to Management seats/Govt. seats, as the case may be. Therefore, candidate who participates in residual seat allotment process (for NRI seat allotment process) and gets this NRI seat is automatically excluded from participation in residual seat allotment process of Non-NRI seats.

Minutes of Meeting of State NEET UG Counseling Board 2021, 09.04.2022

The meeting of UG Counseling Board for admission to MBBS/BDS Course was held under Chairmanship of Dr. Sandeep Tandon, Chairman on 09.04.2022 at RUHS College of Dental Sciences (Govt. Dental College), Jaipur, as per the attendance sheet of 09.04.2022.

Following decisions were taken:

1. Letter no. 1672, dated 08.04.2022 from DME Jaipur was placed before the Board. It was decided to call the candidate Harshika Thirani before the Board on 11.04.2022 and as per the directions of Government to permit to withdraw her resignation and continue with the seat allotted to her at Dr. S.S. Tandia MC, Sriganaganagar.
2. As per observation dated 08.04.2022 of Hon'ble High Court in SBCWP no. 5025/2022 (Sonakshi Kaushik) and in SBCWP no. 5565/2022 (Kiran Meena), only candidates allotted and joined a seat in round 2 state counseling and subsequently allotted a seat in All India stray vacancy round are allowed to resign upto 10.04.2022, 2.00 pm. Colleges are required to return original documents after fulfilling bond conditions and verifying allotment letter downloaded from the official website of MCC. All colleges are directed to keep their office open for this purpose and send the seat matrix by 3.00 pm on the same day.
3. In compliance of order of Hon'ble High Court, Jaipur dated 08.04.2022 in SBCWP No.5565/2022, it was decided to return the documents submitted by the candidate Kiran Meena after fulfilling the bond conditions. The seat so vacated by her will be available to the State Counseling Board for inclusion in stray round.
4. In compliance of order of Hon'ble High Court, Jaipur dated 08.04.2022 in SBCWP No. 5025/2022, it was decided to return the documents submitted by the candidate Sonakshi Kaushik after fulfilling the bond conditions. The seat so vacated by her will be available to the State Counseling Board for inclusion in stray round.
5. In compliance of order of Hon'ble High Court, Jaipur dated 08.04.2022 in SBCWP No. 4997/2022, it was decided to return the documents submitted by the candidate Harsh Vardhan Bagaria and the seat so vacated will be added in stray vacancy round. Further, directions be sought from State Government as to what would be the amount to be paid to the concerned allotted college by the candidate in case, the candidate intends to leave the seat.
6. In view of seats vacated due to above referred court orders, it was decided to re-schedule Residual seats allotment process for Govt. Colleges / RajMES MCs / JMC Jhalawar / RUHS CMS Jaipur, RUHS CDS Jaipur and also all private medical and private dental colleges.
7. Residual seats allotment in Private Dental colleges is re-scheduled and will be held on 11.04.2022 at the venue RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur.
8. Residual seats allotment in Private Medical colleges is re-scheduled and will be held on 11.04.2022 at concerned private medical college.
9. Revised notification for residual seats allotments was finalized.
