The candidates who have qualified the Written Entrance Test are required to appear before the Admission Committee for Interview/Viva-voce for interaction and research aptitude assessment as per below mentioned schedule:

**Date of Interview : 13.08.2023 (Tuesday)**

**Time : 11.00 A.M.**

**Reporting Time : 9:00 A.M.**

**Venue : R.K. Academic & University Block, MGUMST Campus**

Before coming to attend the Interview/Viva-Voce, candidates shall have to self-check and ensure their eligibility for Ph.D. program in all respects. Candidates who do not fulfill the eligibility shall not be allowed for the Interview/Viva-Voce.

Following relevant Original documents and one set of self-attested photocopy of the documents are to be brought by the candidate at the time of Interview/Viva-Voce. Candidates who do not bring all the required original documents shall not be considered for Interview/Viva-Voce in any case. Candidates whose results of the qualifying examination are still awaited, shall also not be allowed for Interview/Viva-Voce:

- Marks sheet/Certificate of the Secondary Examination (10<sup>th</sup> Class) showing date of birth.
- Marks sheet of 10+2 (Senior Secondary) or its equivalent Examination.
- Marks sheet of qualifying examination, as applicable.  
Marks sheet of M.Phil. (Nursing) examination (for the candidates seeking admissions to Ph.D. nursing course).  
Papers published/accepted for publication in National/International Indexed/Referred Journals.
- Valid Certificate for Reservation Category (EWS/SC/ST/OBC-NCL/MBC-NCL etc.) if category is other than General Category.
- No objection certificate/permission from the present employer for the applied regular program (for in service candidate only). Without proper written permission for regular Ph.D. course from the present employer (from the concerned Dean, in case of MGUMST employees), their candidature shall not be considered and accordingly they will not be considered as in-service candidates and will not be allowed for the Interview/Viva-Voce.
- Transfer Certificate from the Institute last attended.
- Character Certificate from the Head of the Institute last attended.
- Copy of Aadhar Card.
- Other relevant certificate(s), if any.



### Criteria for selection:

#### 1. Subjects other than Nursing

A weightage of 70% for the written entrance test and 30% for the performance in the Interview/Viva-Voce shall be given.

#### 2. Nursing

Selection shall be based on:

- (i) Entrance test marks obtained out of 90 marks
- (ii) 5 marks for candidates possessing M.Phil. in Nursing
- (iii) 5 marks weightage for publications

The Admission Committee shall take into account-performance of the candidate both in written entrance test and interview/viva-voce for his/her selection to Ph.D. program. Candidates found suitable for admission in all respect shall be issued provisional admission letter.

### Fees Deposition:

Candidates selected by the Admission Committee for admission to Ph.D. program shall be required to deposit Ph.D. program fee as under:

1	<b>Ph.D. Course Fee - Full Time Course Fee</b> - Rs. 80,000 and two post-dated cheques one each for Rs. 80,000 at the time of admission.	2,40,000
2	<b>Part Time Course Fee</b> - Rs. 80,000 and three post-dated cheques one each for Rs. 80,000 at the time of admission.	3,20,000
3	<b>Caution Money</b>	25,000
4	<b>Ph.D. Course extension Fee</b>	
	i. Full Time beyond 3 years - Per year	80,000
	ii. Part Time beyond 4 years - Per year	80,000

Candidates selected by the Admission Committee for provisional admission to Ph.D. program shall be required to deposit Ph.D. course fee, two/three post-dated cheques and caution money as above latest by Friday, August 30, 2024 in University Bank account through payment link which will be sent to the selected candidates on their registered email.

After deposition of tuition fees and caution money by the selected candidates, they will report to the Principal of the concerned college and to the Head of the concerned department. Required Undertakings/Declarations/Affidavits etc. shall be submitted by the provisionally admitted candidates and their parents in the office of the Principal of the concerned college.
