We kindly submit that as per the permission granted to us under Schedule-II of the Mahatma Gandhi University of Medical Sciences and Technology Act, 2011 to conduct **M.Sc. Nuclear Medicine Technology (NMT)** course, we had applied to the AERB to accord permission to conduct this course. Assessment for the permission by the AERB was also done for M.Sc. (NMT). But the course nomenclature mentioned in your permission letter has been mentioned as "M.Sc. (Nuclear Medicine)" which, as a matter of fact, should have been M.Sc. (Nuclear Medicine Technology). It is therefore requested to **kindly amend nomenclature as M.Sc. (Nuclear Medicine Technology) in place of M.Sc. (Nuclear Medicine).**

Further, it is submitted that we had proposed permission for admission on 15 seats but your above said letter is silent on the intake capacity. 
