Facilities

Medical Facilities and Health Care
An annual complete medical check-up for the entire course is conducted for all the students for which RS. 5000/- are required to be deposited by the student at the time of admission. Every student is also immunized against Hepatitis-B and other infectious diseases where indicated.


Library
Apart from Institutional Libraries, there is an air-conditioned University Central Library, "Dr. K.D. Gupta Knowledge Resource Center" with 600 seating capacity. The timing of the Library is from 9 am to 9 pm on all working days and from 9 am to 5 pm on Sundays. However, The Reading Room facility is available to students 24 hours throughout the year. Remote access for E-resources is also provided. It has internet facilities with accessibility to Medline and Pub-Med with 65 computer terminals, available to all. The library is WiFi enabled.

Hostels

- There are separate hostels for boys and girls in the campus. All hostels are well furnished with dining tables.
- Hostel accommodation to all the students admitted to MBBS and Medical PG courses in the institution is compulsory as to maintain regularity, standard of medical education and discipline. Hostel facility to the students of other courses is provided subject to availability of accommodation.
- Hostel accommodation is allotted only on the production of ID card, copy of hostel fee receipt and joining report of the course submitted to the Principal of the college.

Hostel Rules for both Boys & Girls Hostels

1. Students will be held fully responsible for any loss or damage to electrical fittings, furniture etc., in their room (s).
2. Students should not keep explosive, flammable or gold articles in their rooms. The college holds no responsibility for any loss or theft of any item / cash in the hostels.
3. No student shall permit any stranger / friend / relation / unauthorized person to stay in his / her room even for a short period and if found doing so, the student shall be liable for serious action including expulsion from the hostel.
4. No female shall be allowed to enter the hostel / rooms except the guard room in boys' hostel and vice-versa no male is allowed in the girls' hostels/rooms.
5. All lights and electrical implements must be switched off and water taps must be turned off before leaving the room, failing which a fine will be imposed for each item found switched on when the room is locked.
6. Students are required to write their names and addresses in the register maintained for the purpose with the Warden before leaving for outstation or weekends or holidays after obtaining due permission.
7. No student should be rough to the employees. Any complaint against any employees must be brought to the notice of the Warden immediately.
8. Where mess facility is available, all the students are expected to take their meals at the prescribed time in the hostel Dining Hall or the Mess and not in their rooms.

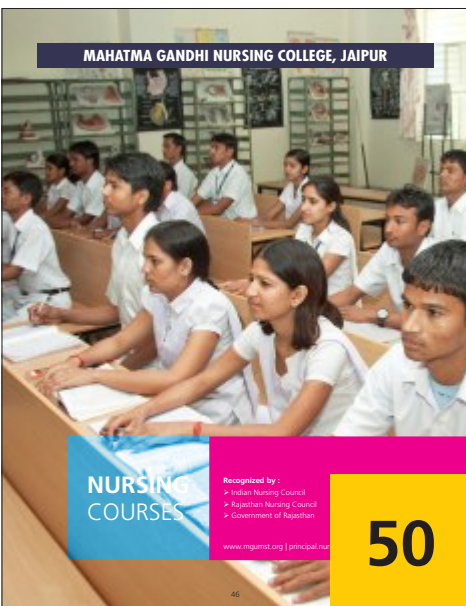

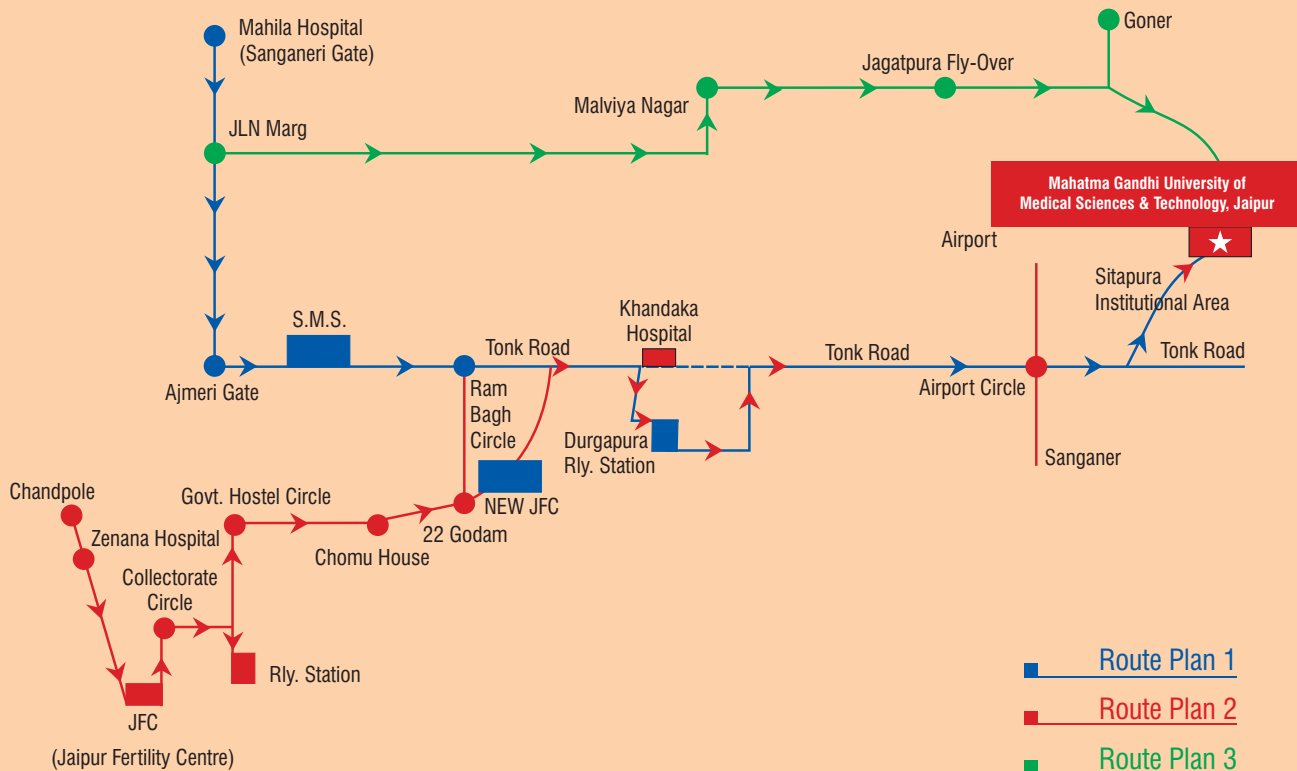

He had his basic In Vitro Fertilization (IVF) training from the University of Liverpool, UK. Library (Dr K.D. Gupta Knowledge Resource Centre)

The Mahatma Gandhi Medical College Library was dedicated in the name of Dr K.D. Gupta on 08th April 2007 and came to be known as Dr K.D. Gupta Memorial Library. In the year 2018, its name "Dr K.D. Gupta Memorial Library" was changed to "Dr K.D. Gupta Knowledge Resource Centre".

The two-storied library building occupies a total area of about 2540 sq. mtrs. It can accommodate 620 users at a time. The Library has a computer lab of 65 computers with Internet & e-library facilities. The Reading facility is available for users 24*7 throughout the year. Library is automated by KOHA-Open Source Software and users can get information from their place about resources availability in the library through Library Open Public Access Catalogue (OPAC) <http://centrallibrary.mgumst.org:7001/>. Library has the Membership of DELNET. The entire area is air-conditioned and well-lighted.

The Library has a collection of 29896 books on various subjects covering atlases, biographies, dictionaries, encyclopaedias, handbooks, manuals, yearbooks as well as other reference books. The Library subscribes 221 national & international print journals. The Library has established an Institutional Digital Repository (ई-संग्रह) using Dspace Software. 178 Research Publications, 62 digital records of theses and dissertations, e-books 53, Rare books 18, Book Chapters 04, Newspaper clipping and last 10 years Question Papers have been uploaded and made accessible to users (IP: <http://182.156.197.210:7003/jspui/>).

Apart from the College Library, every Department has separate Departmental Library.

- Hostels are provided with the facilities of R.O. drinking water, mess with well equipped, modernized kitchen and spacious dining hall, common room, indoor games and dish T.V. Hostels' entrance is guarded by Security guards and CCTV cameras to ensure safety of hostellers. CCTV cameras are also installed at all the floors of the hostels. There are attached wash rooms with geysers.
 - Hostel accommodation to all the students admitted to MBBS and Medical PG courses in the Institution is compulsory so as to maintain regularity, standard of medical education and discipline. Hostel facility to the students of other courses is provided subject to availability of accommodation.
 - Hostel accommodation is allotted merit wise.



Hostel Rules (for both Boys & Girls Hostels)

1. Students will be held fully responsible for any loss or damage to electrical fittings, furniture etc., in their room (s).
2. Students should not keep expensive items or gold articles in their rooms. The college holds no responsibility for any loss or theft of any item / cash of the hotel resident.
3. No student shall permit any stranger / friend / relation / unauthorized person to stay in his / her room even for a short period and if found doing so, the student shall be liable for serious action including expulsion from the hostel.
4. No female shall be allowed to enter the hostel / rooms except the guest room in boys' hostel and vice-versa no male is allowed in the girls' hostel/rooms.
5. All lights and electrical implements must be switched off and water taps must be turned off before leaving the room, failing which a fine will be imposed for each item found switched on when the room is locked.
6. Students are required to write their names and addresses in the register maintained for the purpose with the Warden before leaving for outstation on weekends or holidays after obtaining due permission.
7. No student should be rough to the employees. Any complaint against any employee(s) must be brought to the notice of the Warden immediately.
8. Where mess facility is available, all the students are expected to take their meals at the prescribed time in the hostel Dining Hall or the Mess and not in their rooms.
9. No student should create any disturbance or nuisance for the fellow residents by roaming around in the corridors or staircase. Playing audio systems at late hours during the night is strictly prohibited.
10. Any student found taking drugs or alcohol or in possession of alcoholic drinks or any kind of narcotic / intoxicating drug will be expelled from the hostel. A periodic or / random breath analyzer check to detect level of alcohol in blood may be carried out in the hostels / premises of the University at any time. Disciplinary action will be taken against such student who is found positive for the same and the charges for the test shall be paid by the student, Charges per test –

Rs. 500.00. In addition to this, penalty may be imposed on him. An Affidavit in this regards shall be taken from the students at the time of Admission.

11. Discovery of any lethal weapons or arms in possession of a student, shall invite his expulsion from the college without any enquiry.
12. No student of the hostel shall be absent from the hostel without written permission of the Warden. Students wishing to visit friends or relatives allowed by the parents even on holidays shall obtain prior written permission of the Warden.
13. On working days even if a student goes out with prior sanction or permission, he/she is expected to be back by 8 pm to the hostel.
14. In times of emergency if parents / guardian want the students to visit them, intimation must be sent to College / Hostel through proper channel.
15. Any student found violating any of the above instructions / rules shall render himself to disciplinary action before the committee.
16. Students absent from the hostel without obtaining night passes would also invite disciplinary action, against them.
17. The Principal & Controller of the Institute would decide regulations on matters not included above.

Additional Rules/Instructions for Girls Hostel Residents:

1. Parent / Guardian are expected to produce a list of probable visitors of the student with specimen signature and photograph of those visitors along with their own.
2. If the parent / guardian is not able to produce this on admission he is expected to send the same soon, without which no visitor would be permitted to meet the hosteller.
3. Nobody else will be allowed to meet or take the student out either from the college or from the hostel.
4. Persons other than those who bring letter from the parents / guardian or those other than from the authorized list will in no way be permitted to meet / take the student out.
5. During holidays parent / guardians are expected to accompany or send authorization letters to the College, failing which the student will not be allowed to leave the hostel.

6. The student is expected to reach the hostel at the stipulated time and sign the register kept for the purpose on entry, which will be checked periodically.
7. Outings and shopping must be intimated to the authority concerned and prior permission must be obtained with statement of check out and check in timings failing which disciplinary action will be taken.
8. No male relatives will be allowed to enter inside the hostel rooms. Their entry will be restricted to the visiting room.
9. Female relatives/friends are allowed to visit the inmates but they can not stay beyond 8 pm.
10. Students are expected to attend college on the reopening day after vacation. No excuse will be considered.

Discipline

A candidate selected for admission shall be subject to the disciplinary rules of the Institution.

If any candidate / authorized representative or accompanying person is found obstructing the admission process, trying to influence in unlawful manner / creating nuisance then the candidate shall be liable for disqualification from the process of selection. The decision taken by the institution in this respect shall be final and binding as well.

Reservation in Admissions

As per Section 32(3) of the Mahatma Gandhi University of Medical Sciences and Technology Act, 2011, reservation in admission to the University for scheduled castes, scheduled tribes, backward classes of Rajasthan, special backward classes of Rajasthan , women and handicapped persons shall be provided as per the policy of the State Government prevailing at the time of Admission.

Students of reserved category of other states are advised to go through the reservation policy of the Government of Rajasthan before claiming for admission on reserved category seats in the institution of the MGUMST.

Teaching Days

Program wise teaching days & teaching hours in the colleges of the University shall be as per the regulations of the concerned statutory regulating body viz NMC, DCI, INC, RCI. For the programs which are not regulated by any of the above bodies, the teaching days and hours shall be as per the regulations of the MGUMST.

NO RAGGING

Prevention and Prohibition of Ragging

Ragging of fresher / junior is strictly prohibited in and outside the campus of the university. Those, who are found guilty of ragging / abetting ragging, shall be punished severely as per the relevant regulations of the NMC / DCI / INC / RCI / UGC and the provisions of the Act of the Central Government and the State Government.

"Ragging" includes the following:

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Punishable ingredients of Ragging:

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;

- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim(s);
- Physical or psychological humiliation.
- All other offences following from the definition of "Ragging"

Ragging shall be considered as a cognizable offence under the law at par with rape and other atrocities against women and ill treatment of persons belonging to the SC / ST. Strict action shall be taken against those found guilty of ragging or of abetting ragging. Online undertaking of the effect that he/she is aware of law regarding prohibition to ragging as well as the punishment and further that he/she has not been expelled and/or debarred from admission by any institution and he/she is found guilty of the offence of ragging and/or abetting ragging is liable to be punished appropriately including even arrest by police, by each student and every parent is to be submitted in every academic year including year of admission as per the D.O. letter no. F 3-2/2021 (ARC) dt. 27.10. 2021 of

the Secretary, UGC, New Delhi. (Website for online undertaking is - www.antiragging.in and www.amanmovement.org). The student will receive an E-mail with his/her registration number and a weblink. Awardable Punishments at the College / Institution level:

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- Suspension from attending classes and academic privileges.
- Withholding / withdrawing scholarship / fellowship and other benefits
- Debarring from appearing in any test / examination or other evaluation Process.
- Withholding results
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension / expulsion from the hostel
- Cancellation of admission.
- Rustication from the institution for period ranging from 1 to 4 semesters
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- Fine of Rs. 25,000.00 and Rs. 1 lakh.
- Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

University Rules and Regulations

All students shall abide by the University/College Rules & Regulations and Code of Conduct. Important ones are mentioned below :

1. Regularity and punctuality in lectures, demonstrations, practical, clinical and class examinations are compulsory. Students, who do not show satisfactory progress and are found shallow in their conduct, will not be allowed to appear in the University examinations. Students, who do not maintain a satisfactory academic standard and conduct, will not be allowed to hold any office in the College or participate in any extracurricular activities.
2. Minimum required attendance as per the regulations of the NMC / DCI / INC / RCI / MGUMST is compulsory. Any one failing to achieve this, shall not be allowed to appear in the University examination.
3. Each and every student of the University shall have to undergo and successfully complete Basic Life Support (BLS) Course before appearing at the University Final Year Examination of the program in which he / she has taken admission. No extra charges shall be taken from the students for the BLS Course.
4. Students are not allowed to paste any notice(s) within the Institute, without prior permission from the office of the Principal. They are also forbidden to communicate with any outside agency / authority directly. All such communications must be submitted to the Principal, who will forward these to the University, if considered necessary. Any student infringing this rule may be suspended.
5. The College does not hold itself responsible for debts incurred by the Students.
6. **No motor driven vehicle is allowed in the University campus.** An undertaking to this effect has to be furnished by every candidate at the time of admission.
7. Without getting enrolled with the University, no student will be allowed to appear in the University examination.
8. Use of unfair-means at the University examination will invite punishment as per relevant rules/regulations.
9. Strictly forbidden in or outside the university campus are:
 - a) Demonstration, Strike
 - b) Possession or use of alcoholic beverages, narcotic drugs, Pep pills, Cigarette, tobacco,

pan masala, addictive or hallucinogenic drugs, single use plastic items, firearms or any lethal weapons.

- c) Gambling
- d) Loitering around, especially under the influence of alcohol.
- e) Use of vulgar language, violence

Violation of these rules and regulations shall be viewed by the authorities as a serious offence and it may lead to disciplinary action even leading to suspension / expulsion from the college. Dancing in the College premises is discouraged.

10. Student(s) shall have to pay for all damages caused by him/them to instruments, books, equipments and other property of the college/ university.
11. Any illness or / and minor ailment must be reported to the Principal or Warden as early as possible.
12. Students must arrange for the Uniform prescribed by the college Principal, washable white coats, which are to be worn at all times in the college, laboratories and on hospital duty and also for their own dissecting instruments. Girls must put their hair up when at study in the college or hospital.
13. College fees must be paid in full by the dates specified by the Principal. Any student whose fee, together with the fine if imposed, is still unpaid will be suspended from attending lectures/practical.
14. Indiscipline of any kind shall be an offence punishable by orders amounting to even the expulsion of the student.
15. The College is basically residential providing all amenities for physical and spiritual well being of the students.
16. Hostel accommodation to all the students admitted to MBBS and Post Graduate Medical Courses is compulsory so as to maintain regularity, standard of medical education and discipline.
17. Sick leave: In all cases of illness recommendation of sick leave in writing by the Warden or Medical Officer must be presented to the Principal. Further, students should present sick leave certificate to the Principal after presenting the leave slips to the department concerned.
18. Other leaves: Taking leave during the term is discouraged. However, if urgently required for

any reason, parents or legal guardian of the hosteller should apply with a letter to the Principal through the Warden. Application should be sent well in advance. Students should inform the Warden before leaving the hostel when they proceed on weekend or any other leave. All students are required to inform the Principal and Warden in writing before they leave the hostel for more than 24 hours.

19. Official Leave: Students requiring leave for taking part in sports or games on behalf of the College should apply to the Principal through the Warden. Application should be sent well in advance.
- 20.. Medical Examination: All the candidates provisionally selected for admission to various courses will be examined by the Medical Board duly constituted by the Principal & Controller of the MGMC&H on the basis of criteria evolved for medical examination by the Principal & Controller regarding their general and physical fitness.
21. The University reserves the right to make changes in the Guidelines, Fee – Structure or any other information at any time without prior notice. The decision of the University shall be binding on all.
22. Amendments in the regulations made and notified from time to time by the NMC / DCI / INC / RCI / UGC or the Central / State Government shall be automatically effective for the MGUMST.
22. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the Notification / Rules, the University shall cancel his / her admission at any stage.
24. Qualifying Examination should have been passed from the UGC recognised University / Govt. recognised Board, as the case may be.
25. Every admitted student has to strictly follow the code of conduct and give an Undertaking / Declaration as per the format prescribed by the University on page no. - 16 of this prospectus.
26. All disputes in relation to the matters pertaining to admission to any course of the University shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.

Admission to MD/MS Courses

Admission to MD/MS Courses in Mahatma Gandhi Medical College & Hospital (MGMCH), Jaipur - a unit of MGUMST, Jaipur for the academic year 2023-24 shall be governed by the :

1. Norms prescribed for entrance test (NEET PG – 2023) and counseling prescribed by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India.
2. Act and Statutes of Mahatma Gandhi University of Medical Sciences and Technology.
3. Directions / orders of Hon'ble Supreme Court of India from time to time.
4. Directions / Orders of Government of India and The Government of Rajasthan.

Only the candidates who have qualified the NEET-PG 2023 shall be eligible for admission to the Postgraduate MD / MS Courses . Admissions shall be made by NEET PG Medical and Dental Admission / Counseling Board - 2023 constituted by the Govt. of Rajasthan, on the basis of merit marks obtained by candidates at NEET-PG 2023 conducted by the National Board of Examination, New Delhi. To participate in the process of admission, it is mandatory for the candidates to get themselves registered with the NEET PG Medical and Dental Admission /Counseling Board - 2023 constituted by the Govt. of Rajasthan.

Prospective candidates are advised to go through the 'Information Bulletin of NEET PG 2023 for

complete information regarding the examination conducted by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India and the counseling process for admissions in the institutes offering PG medical courses etc.

MGMCH, Jaipur has been offering various PG - MD / MS Courses which are duly approved/recognized by National Medical Commission/ Ministry of Health & Family Welfare, Govt. of India.

RESERVATIONS -

Reservation in admissions to MD/MS Courses shall be made by the NEET PG Medical and Dental Admission /Counseling Board - 2023 as per the Reservations policy of the Govt. of Rajasthan prevailing at the time of Admission.



Eligibility

(A) No candidate of any category (including Management quota) shall be eligible for admission to MD/MS courses in Mahatma Gandhi Medical College & Hospital, Jaipur, if he/she has not qualified NEET-PG 2023.

(B) Every candidate, being selected for admission to postgraduate medical course should possess:

1. MBBS degree or Provisional MBBS Pass Certificate recognized as per the provisions of the Indian Medical Council Act 1956.
2. Permanent or provisional registration certificate of MBBS qualification issued by the Medical Council of India or State Medical Council.
3. Internship completion certificate showing the completion of the internship on or before 11th August 2023.
4. Qualifying certificate cum marks statement of NEET PG 2023 issued by the National Board of Examinations, New Delhi.

(C) Management Seats

15% of total number of seats available in MD/MS courses have been earmarked for Management Quota.

Eligibility for Admission on Management Quota seats shall be as per the decision of the NEET PG Medical / Dental Admission / Counseling Board-2023 constituted by the Government of Rajasthan.

(D) Foreign Medical Graduates

Indian citizens or overseas citizens of India who have obtained their Primary Medical Qualifications from Medical Colleges outside India should have qualified the Foreign Medical Graduate Examination (Screening Test) which is conducted by National Board of Examinations. Further, they should have been registered with NMC/SMC and should have completed their internship on or before 11.08.2023.

(E) Foreign Nationals

1. It is not mandatory for foreign nationals to have temporary registration with NMC at the time of appearing at the NEET-PG 2023. They can appear at the NEET-PG without NMC registration. The National Medical Commission may, on payment of the prescribed fee for registration, grant temporary

registration for the duration of the Post Graduate course limited to the Medical college - Mahatma Gandhi Medical College & Hospital, Jaipur to which he/she is admitted for the time being exclusively for pursuing postgraduate studies. Provided further that temporary registration of such foreign national shall be subject to the condition that such person is duly registered with appropriate registering authority in his own country where from he has obtained his Basic Medical qualification, and is duly recognized by the corresponding Medical Council or concerned authority.

2. Students from other countries should possess passport, visa and exchange permits valid for the entire period of their course of study in this Institution and should also observe the regulations of both central and state governments regarding residential permits and obtain no-objection certificate etc., from time to time.

3. The student should have a provisional "Student Visa". If he/she comes on any other visa and is selected for admission, he will have to first obtain a student visa from competent authority and then only he/she will be allowed to join the course. Therefore it is imperative to obtain provisional student visa before coming for Counseling.

(F) Registration with NMC/SMC

1. Every student, selected for admission to a Post Graduate medical course in Mahatma Gandhi Medical College & Hospital, Jaipur on acquiring MBBS Degree or an equivalent qualification thereto shall have to obtain permanent registration with the NMC/SMC within a period of one month from the date of his/her admission, failing which his/her admission to PG Medical Course in Mahatma Gandhi Medical College & Hospital, Jaipur shall stand cancelled and no claim for refund of fees shall be entertained.

2. For Foreign Nationals, Clause **(D)** as above shall apply.

Selection of Postgraduate Students

Admissions on all the 167 seats including 25 seats of Management Quota shall be made in Mahatma Gandhi Medical College & Hospital, Jaipur on the basis of merit marks obtained by the candidates in National Eligibility Cum Entrance Test NEET - PG 2023 conducted by National Board of Examinations (NBE) New Delhi governed by the Rules and Regulations specified by the Government of India, Ministry of Health & Family Welfare/Directorate General Health Services/and orders of Hon'ble Courts.

Admissions will be given as per the seat sharing matrix from amongst the NEET-PG 2023 qualified candidates on merit basis.

Reservation would be made applicable by the **NEET PG Medical / Dental Admission/Counseling Board - 2023** constituted by the Government of Rajasthan as per the reservation policy of Government of Rajasthan.

Admission policy may be changed according to the law prevailing at the time of counseling / admission.

Seat Allotment and Counseling:

Seat Allotment and Counseling of the candidates who qualify the NEET-PG 2023 and are eligible for admission to MD/MS Courses in Mahatma Gandhi Medical College & Hospital, Jaipur will be done by the **NEET PG Medical / Dental Admission/Counseling Board - 2023** constituted by the Government of Rajasthan. It is mandatory for the NEET-PG qualified candidates to get themselves registered with the Rajasthan NEET-PG Medical / Dental Admission / Counseling Board - 2023, otherwise they will not be considered for seat allotment and admission.

All admissions shall remain provisional at the first instance subject to effective enrolment with affiliating University- MGUMST, Jaipur in a time bound manner.

Period of Training

The period of training for obtaining Post graduate degrees (MD/MS) shall be three complete years including the period of examination.

However, it shall be two years for candidates who have obtained the recognised PG Diploma in the particular subject.

80% attendance in each course is compulsory. Any one failing to achieve this, shall not be allowed to appear in the University examination. Students will be allowed 10 days leave in every 6 months. These will not be cumulative i.e. unavailed leave shall not be forwarded to next span of six months. Students will also be allowed 1 day off every week.

As decided by the Academic Council of the MGUMST

in its meeting held on December 13, 2017 duly approved by the Board of Management of the University on December 21, 2017, academic performance of the students admitted to MD/MS PG Medical Courses in the academic year 2019-20 and onwards shall be assessed during their three years course duration before their university final examinations. There shall be 6 internal assessment tests during their three years duration course, with a gap of every 4 to 6 months. These internal assessment tests shall be conducted by the concerned department. The students will be required to qualify at least 3 internal assessment tests by securing at least 50% marks in each internal assessment test.

The students will also be required to fulfil other eligibility conditions like publication of papers, attending seminars/conferences etc as per the regulations of the The National Medical Commission for PG MD/MS Courses before they are allowed to appear at the University Examinations.

Skill Development Program

The students during their training program shall be required to undertake either of the two Skill Development Programs - Advanced Trauma Life Support (ATLS) or Advanced Cardiac Life Support (ACLS) so as to become eligible to appear in the university examination at the end of Third year. In addition, they can also undertake Paediatrics Advanced Life Support (PALS) program, if they intend.

The students of MD (Paediatrics) shall have to undertake PALS program. In addition, they can also undertake ATLS or ACLS program, if they intend.

Such a student who has already successfully completed ATLS / ACLS or PALS program, as the case may be, from the MGMC&H or elsewhere will be exempted to do the same again. For claiming the exemption, the student shall be required to submit ATLS / ACLS or PALS program completion certificate in the office of the Principal, MGMC&H.

Stipend

Students admitted to the MD/MS courses in Mahatma Gandhi Medical College & Hospital will be paid stipend during their training period at par with the State Government.

Management Quota seats shall be filled as per state reservation policy and preference will be given to Rajasthan state domicile. All India candidates do not require domicile certificate.

Eligibility Criteria –

1. Eligibility for admission to MBBS course shall be as laid down in the Notification/Information Booklet issued by the Chairman, NEET UG Medical & Dental Admission/Counseling Board-2023.
2. The candidate must have passed 10+2 or equivalent examination in the subjects of Physics, Chemistry, Biology/Bio-technology and

English individually and must have obtained a minimum of 50% marks (45% in case of Person with Disabilities & 40% in case of reserved caste category candidates) taken together in Physics, Chemistry and Biology/Biotechnology at the qualifying examination as mentioned in the Graduate Medical Education Regulations, 1997 as amended from time to time.

The students educated abroad seeking admission in Mahatma Gandhi Medical College & Hospital, Jaipur must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English up to the 12th standard level with 50% marks and their equivalency determined as per regulations of the NMC (Medical Council of India) and the University.

3. The candidate must have qualified National Eligibility cum Entrance Test (NEET) UG – 2023 conducted as per regulations framed under the Indian Medical Council Act – 1956 as amended from time to time.
4. The candidate must fulfill the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the Government of India, the Government of Rajasthan and the MGUMST.
5. The candidate must have completed the age of 17 years on or before 31st December of the year of his/her admission to the 1st year MBBS course.
6. The upper age limit of the candidate is 25 years on the date of NEET – UG of the year of admission with relaxation of 5 years for the candidates belonging to SC/ST/OBC category and persons entitled for reservation under the Right of Persons with Disabilities Act, 2016.

Reservation –

Reservation of the seats for respective categories shall be made by the NEET UG Medical & Dental Admission/Counseling Board – 2023 constituted by the Govt. of Rajasthan as per applicable Reservation Policy of Government of Rajasthan prevailing at the time of admission.

Foreign Students

Foreign students from other countries should possess passport, visa and exchange permits valid for the period of their course of study in this Institution and should also observe the regulations of both central and state governments regarding residential permits and obtain no-objection certificate.

The candidates should have provisional "Student Visa". If they come on any other visa and are selected for admission, they will have to first obtain Student Visa from the competent authority and then only they will be allowed to join the course. Therefore it is imperative to obtain provisional Student Visa before coming for counseling by the Admission Board.

Selection procedure and admission

The NEET UG-2023 qualified candidates desirous to seek admission in MBBS course in Mahatma Gandhi Medical College and Hospital, Jaipur shall be required to get themselves registered with the NEET UG-2023 Counseling / Admission Board constituted by the Govt. of Rajasthan for the academic year 2023-24. Admissions on all the seats including Management Quota will be granted through a common counseling conducted by NEET UG Medical / Dental Admission / Counseling Board-2023 on the basis of merit marks obtained by the candidates at NEET UG-2023. Admission Schedule shall be as per the notification issued in this regard by the NMC/Govt. of India/ Hon'ble Rajasthan High Court / Supreme Court of India.

The Date of commencement of academic session shall be as per National Medical Commission, New Delhi. In case where the student has been admitted to the

course after the commencement of classes through the waiting list or otherwise on or before the last date of admission of the academic year, the period of training and duration of the course will be reckoned from the date of commencement of classes and not from the date of his actual admission.

Cancellation of Admission & Withdrawal from the course :

The admission of the student, who has paid the admission fee but fails to join the course at the institute within the time limit communicated, is liable to be cancelled, and the tuition fee paid will not be refunded.

In case, the Eligibility / Equivalent certificate is not produced by the candidate within the prescribed period, his / her selection for admission to the MBBS course is liable to be cancelled.

The prescribed fee once paid shall not be refunded in any case. If, after admission, any student withdraws from or discontinues the course he / she shall have to pay the entire course fee. Only the Caution money (interest free refundable amount) after adjustments, if any, will be refunded.

1. Norms prescribed for entrance test (NEET MDS – 2023) and counseling prescribed by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India.
2. Act and Statutes of Mahatma Gandhi University of Medical Sciences and Technology.
3. Directions / orders of Hon'ble Supreme Court of India from time to time.
4. Directions / Orders of Government of India and the Government of Rajasthan.

Only the candidates who have qualified the NEET-MDS 2023 shall be eligible for admission to the Postgraduate MDS Courses. Admissions shall be made on the basis of merit marks obtained by candidates at NEET-MDS 2023 conducted by the National Board of Examination, New Delhi.

Prospective candidates are advised to go through the '**Information Bulletin of NEET MDS 2023**' for complete information regarding the examination conducted by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India and the counseling process for admissions in the institutes offering PG dental courses etc.

MGDCH, Jaipur has been offering various PG - MDS Courses which are duly recognized by Dental Council of India / Ministry of Health & Family Welfare, Govt. of India.

RESERVATIONS

Admission to MDS Courses shall be made as per the policy of the Govt. of Rajasthan prevailing at the time of Admission.



Eligibility

(A) No candidate of any category shall be eligible for admission to MDS courses in Mahatma Gandhi Dental College & Hospital, Jaipur if he/she has not qualified NEET-MDS 2023.

(B) Every candidate, being selected for admission to postgraduate dental course should possess.

1. BDS degree or Provisional BDS Pass Certificate recognized as per the provisions of the Dental Council of India.

2. Permanent or provisional registration certificate of BDS qualification issued by the State Dental Council.

3. Internship completion certificate showing the completion of the internship on or before 30th June 2023.

4. Qualifying certificate cum marks statement of NEET-MDS 2023 issued by the National Board of Examinations, New Delhi.

(C) Foreign Dental Graduates

Indian citizens or overseas citizens of India who have obtained their Primary Dental Qualifications from Dental Colleges outside India should have qualified the Foreign Dental Graduate Examination (Screening Test) which is conducted by National Board of Examinations. Further, they should have been registered with DCI/SDC and should have completed their internship on or before 31.07.2022.

(D) Foreign Nationals

1. It is not mandatory for foreign nationals to have temporary registration with DCI at the time of appearing at the NEET-MDS 2023. They can appear at the NEET-MDS without DCI registration. The Dental Council of India may, on payment of the prescribed fee for registration, grant temporary registration for the duration of the Post Graduate course limited to the Dental college - Mahatma Gandhi Dental College & Hospital, Jaipur to which he/she is admitted for the time being exclusively for pursuing postgraduate studies. Provided further that temporary registration to such foreign national shall be subject to the condition that such person is duly registered with appropriate registering authority in his own country where from he has obtained his Basic Dental qualification, and is duly recognized by the corresponding Dental Council or concerned authority.

2. Students from other countries should possess passport, visa and exchange permits valid for the entire period of their course of study in this Institution and should also observe the regulations of both central and state governments regarding residential permits and obtain no-objection certificate etc., from time to time.

3. The student should have a provisional "Student Visa". If he/she comes on any other visa and is selected for admission, he will have to first obtain a student visa from competent authority and then only he/she will be allowed to join the course. Therefore it is imperative to obtain provisional student visa before coming for Counseling.

(E) Registration with State Dental Council (SDC)

1. Every student, selected for admission to a Post Graduate dental course in Mahatma Gandhi Dental College & Hospital, Jaipur on acquiring BDS Degree or an equivalent qualification thereto shall have to obtain permanent registration with the DCI/SDC within a period of one month from the date of his/her admission, failing which his/her admission to PG Dental Course in Mahatma Gandhi Dental College & Hospital, Jaipur shall stand cancelled.

2. For Foreign Nationals, Clause **(D)** as above shall apply.

Selection of Postgraduate Students

Admissions on all the 31 seats shall be made in Mahatma Gandhi Dental College & Hospital, Jaipur on the basis of merit marks obtained by the candidates in National Eligibility Cum Entrance Test NEET-MDS 2023 conducted by National Board of Examinations (NBE) New Delhi governed by the Rules and Regulations specified by the Government of India, Ministry of Health & Family Welfare/Directorate General Health Services/and orders of Hon'ble Courts.

Admissions will be given as per the seat sharing matrix from amongst the NEET-MDS 2023 qualified candidates on merit basis.

Reservation would be made applicable as per the reservation policy of Government of Rajasthan.

Admission policy may be changed according to the law prevailing at the time of counseling / admission.

Counseling:

Counseling and seat allotment of the Candidates who qualify the NEET-MDS 2023 and are eligible for admission to MDS Courses in Mahatma Gandhi Dental College & Hospital, Jaipur will be done by the **NEET PG Medical and Dental Admission / Counseling Board -2023** constituted by the Government of Rajasthan.

All admissions shall remain provisional at the first instance subject to effective enrolment with affiliating University - MGUMST, Jaipur in a time bound manner.

Period of Training

The period of training for obtaining Post graduate degrees (MDS) shall be three complete years including the period of examination.

80% attendance per year in each course is compulsory. Any one failing to achieve this, shall not be allowed to appear in the University examination. Students will be allowed 10 days leave in every 6 months. These will not be cumulative i.e. unavailed leave shall not be forwarded to next span of six months.

As decided by the Academic Council of the MGUMST in its meeting held on December 13, 2017 duly approved by the Board of Management of the University on December 21, 2017, academic performance of the students admitted to MDS PG Dental Courses from the academic year 2019-20 shall be assessed during their three years course duration before their university final examinations. There shall be 6 internal assessment tests during their three years duration course, with a gap of every 4 to 6 months.

These internal assessment tests shall be conducted by the concerned department. The students will be required to qualify at least 3 internal assessment tests by securing at least 50% marks in each internal assessment test.

The students will also be required to fulfil other eligibility conditions like completion of clinical quota, publication of papers, attending seminars / conferences etc. as per the regulations of the Dental Council of India for PG (MDS) Courses before they are allowed to appear at the University Examinations.

Note

Candidates, at the time of their admission, shall be required to submit necessary Undertakings, Affidavits Surety Bonds in Mahatma Gandhi Dental College & Hospital.

Categories of seats -

- a.** Management Category seats – 15% of total intake - 15 Seats
Management Quota seats shall be filled as per state reservation policy and preference will be given to Rajasthan state domicile. All India candidates do not require domicile certificate.
- b.** State Quota seats - 85% of total intake - 85 Seats

Eligibility Criteria -

1. The candidate must have passed 10+2 or equivalent examination in the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum

of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination as mentioned in the Dental Council of India Revised BDS Course Regulations 2007 as amended from time to time.

In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes or Other Backward Classes, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examinations shall be 40% marks instead of 50% marks for General category candidates. The students educated abroad seeking admission in Mahatma Gandhi Dental college, Jaipur must have passed in the subjects of Physics, Chemistry, Biology and English up to the 12th standard level with 50% marks and their equivalency determined as per regulations of the Dental Council of India and the University.

2. The candidate must have qualified National Eligibility cum Entrance Test NEET UG – 2023.

Foreign Students

Foreign students from other countries should possess passport, visa and exchange permits valid for the period of their course of study in this Institution and should also observe the regulations of both central and state governments regarding residential permits and obtain no-objection certificate.

Admissions on all the seats including Management quota seats will be granted through a common counseling conducted by NEET UG Medical / Dental Counseling / Admission Board - 2023 on the basis of merit marks obtained by the candidates at NEET UG-2023. Admission Schedule shall be as per the notification issued in this regard by the DCI / Govt

The Date of commencement of academic session shall be as per Dental Council of India, New Delhi. In case where the student has been admitted to the course after the commencement of classes through the waiting list or otherwise on or before the last date of admission of the academic year, the period of training and duration of the course will be reckoned from the date of commencement of classes and not from the date of his actual admission.

Cancellation of Admission & Withdrawal from the course :

The admission of the student, who has paid the admission fee but fails to join the course at the institute within the time limit communicated, is liable to be cancelled, and the tuition fee paid will not be refunded.

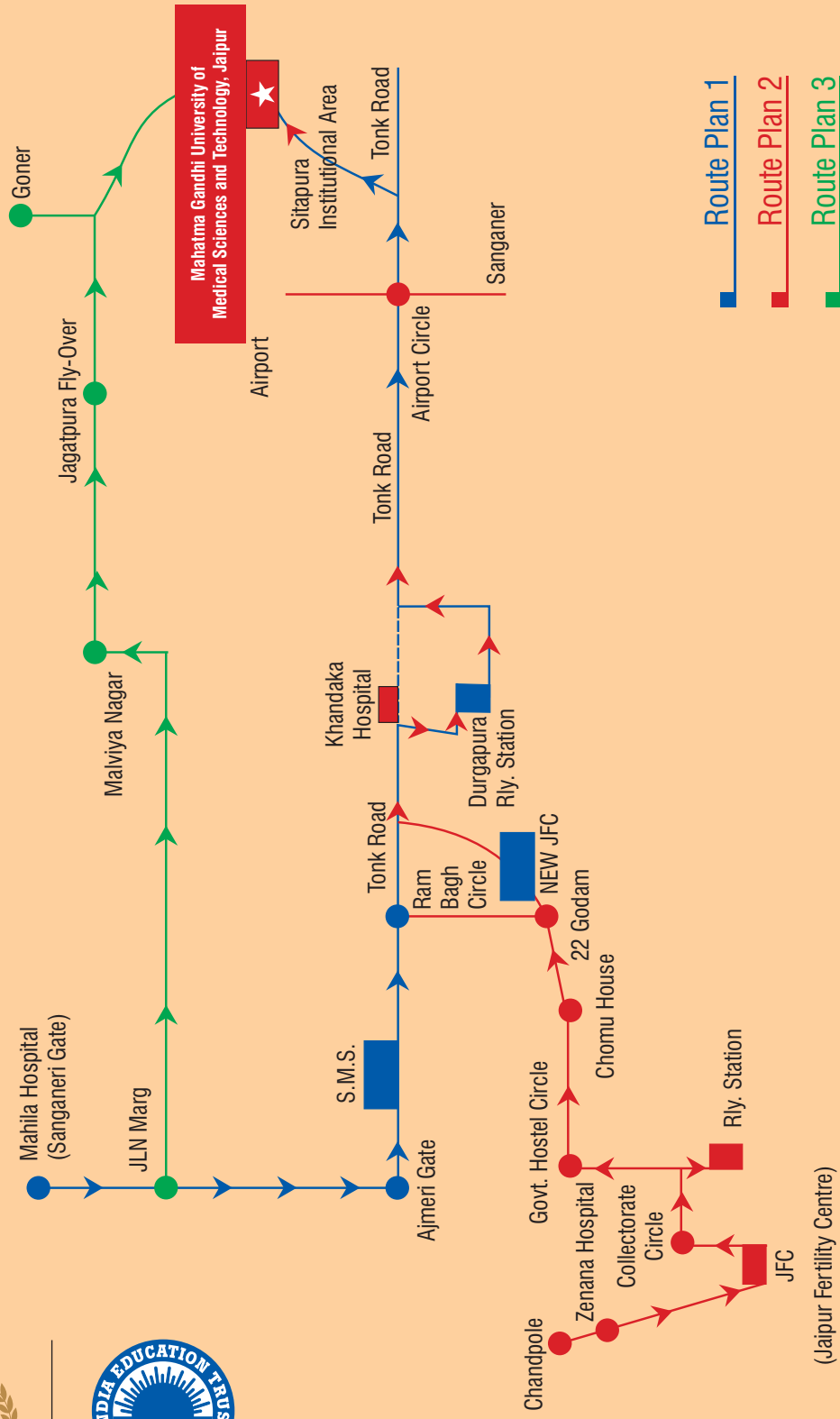
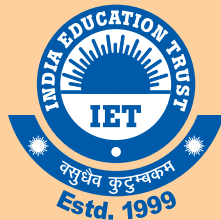
