Following candidates are eligible for Stray Vacancy Round and must fill choices to participate in Stray Vacancy Round :

1. Earlier registered candidates who did not get allotment in Round 1, Round 2 and Round 3.
2. Round 1 candidate allotted and joined but resigned after Round 2 without forfeiture of security amount.
3. Newly registered candidates.

All NEET MDS-2024 qualified & eligible candidates desirous to take admission in MDS courses in Mahatma Gandhi Dental College & Hospital, Jaipur are advised to fill choices on the website www.rajmdsneet2024.org of the Rajasthan State NEET PG Admission/Counseling Board-2024.

FEES STRUCTURE

A. Tuition Fee.

1.	Oral & Maxillofacial Surgery	Rs. 7 Lacs (Rupees Seven Lacs) only.
2.	Paediatric & Preventive Dentistry	Rs. 6 Lacs (Rupees Six Lacs) only.
3.	Periodontology	Rs. 5 Lacs (Rupees Five Lacs) only.
4.	Oral Medicine and Radiology	Rs. 3 Lacs (Rupees Three Lacs) only.

In addition to the 1st year tuition fees as mentioned above against the subjects, the candidate has to submit two post-dated cheques of equal amount as tuition fee for next two years of the course in favour of Mahatma Gandhi University of Medical Sciences and Technology, Jaipur.

1st year tuition fees will be deposited in the bank account of Chairman, NEET PG Admission/Counseling Board, 2024.

B. Caution Money (For all subjects) -

Rs. 2 Lacs (Rupees two lacs) only to be deposited at the time of admission. This will be interest free refundable amount on completion of the course.

Caution money shall be accepted through NEFT/Direct Bank Transfer or through Demand Draft. In case the money is deposited through DD, the DD should be in favour of **Mahatma Gandhi University of Medical Sciences and Technology** payable at Jaipur. 1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. **For participation in stray vacancy round, it is mandatory for candidates to come for document verification and submit all relevant original documents with the board. Candidates whose documents are not verified or who do not submit his /her documents, will not be allowed to participate in stray vacancy round.**
3. Candidate shall also submit a bond in prescribed format mentioning that- (i) He/she will join the course within stipulated period. (ii) If he/she does not join the course, he/she will be liable to pay amount equal to the fee of entire course of the allotted college, to the allotted college (iii) If he/she fails to comply the above conditions, his/her original documents will be retained by the allotted college.
4. All fresh candidates are required to deposit non-refundable application fee of Rs. 4000/- (Rs. 3000/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.
5. The candidates are advised to visit the websites regularly for registration and other relevant information.

Important: If a candidate is allotted a seat in stray vacancy round and does not join the allotted seat/college, he/she shall be debarred from participating in State Counselling Process for next one year.
